- 2. Declarations of Interest: None declared
- 3. The minutes of the Parish Council meeting held on 26 July 2017 were agreed and signed by the Chair.
- 4. Matters arising from Minutes
  - A. Otterpool Garden: No news to report
  - B. Parish Website: After completing the required documents to forward the existing domain name to Mr O'Gilvie's Company, it transpires that this was not possible without spending money to be on an approved list. The only solution for Postling Parish Council is to purchase a new domain name with Mr O'Gilvie's company at an annual cost of £9 plus hosting fee for an annual amount of £25. It was deemed this solution is better than to wait and see what the current provider will charge in future. This was proposed acceptable by Cllr Pattrick, seconded by Cllr Elphick and unanimously agreed this was the way forward. Clerk is to follow up on timing and names available.
