- 5. Planning Applications:

It has been reported that NO CD's of any planning applications have been received.

Y16/0296/SH, Postling Lodge, Farthing Common, Lyminge, Section 73 Application to vary condition 3 of planning Permission Y15/0948/SH to enable alterations to the design. Planning application was withdrawn.

Y16/0844/SH, Land adjoining Orchard Cottage, The Street, Postling, Felling of 2 Western Red Cedars (T7 and T9); 1 Leyland Cypress (T8) and 1 unidetified tree (Roaceae Species) (T6), All subject of tree preservation order no 12 of 1988. Postling Parish Council supports this planning.

Y16/0635/SH, Land adjoining Orchard Cottage, The Street, Postling, Construction of a detached dwelling house and garage. Paper plans were obtained from the applicant and have been discussed. Cllr Reynolds proposed to support this planning application. This was seconded by Cllr Christine Hobbs and unanimously agreed. In addition, the Parish Council wish to comment:-

Based on drawings shown for 1 dwelling Yew hedge at the front to be reinstated Parking during construction must be kept within the plot As much of the front stone wall as possible to be retained

6. Lorry Park Consultation ends on Friday 23 September. Cllr Frank Hobbs read out KALC's response, signed by Cllr John Wilson, Chairman of the Transport Advisory Committee. KALC is calling for alternative solutions. Cllr Hollingsbee read out Shepway's response to the HE Consultation.

Postling's Parish council comment is:-

"South of the M20, where the current Stop 24 is, Postling Parish Council fully supports the expansion of the lorry park to provide overnight facilities. We urge Government to legislate to make it easier for local Authorities to force lorries to use the park instead of parking inappropriately.

For the North side, we argue that this is not necessary and will not solve Operation Stack. Highways England must look for alternative smaller sites.

Part of the site, adjoining Stanford Village, and the area close to Gibbons Brook Farm should not be used for parking but included in the mitigation measures. Should the lorry park go ahead, Junction 11 of the M20 must remain fully open at all times. If the off-slip road is closed it will cause significant disruption to local traffic and villages."

Cllr Frank Hobbs read out Dr Priest's email calling out for a Community Forum. We agreed it was a good idea and would support such meetings. He also read out an email from the Chairman of Stanford PC calling for a juridical Review, which needs funding. It was agreed that Postling PC was not able to donate any funds.
